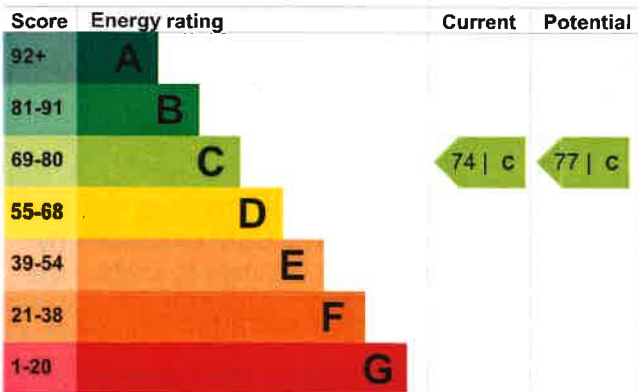
The graph shows this property's current and potential energy efficiency.

Environmental impact of this property
